- > Vehicle must not have been totaled, stolen, exported from the US, imported to the US from another country or have branded title.
- > The Audi CPO Limited Warranty is only eligible to be transferred from private owner to private owner and must be requested by the original purchaser of the CPO vehicle. Dealership participation is excluded.
- > Transfer application must be submitted by the original Certified pre-owned owner within 30 days of vehicle sale.
- > The original CPO sale date must be prior to August 1, 2023*

Audi of America reserves the right to refuse transfer in the case of fraud, abuse, failure to meet transfer guidelines, or if the appropriate documentation is not submitted.

*The Audi CPO limited warranty is transferable to a subsequent purchaser only for vehicles with a CPO sale date prior to August 1, 2023. For CPO sales dated on or after August 1, 2023, the CPO limited warranty is non-transferable, and can only be utilized by the original CPO purchaser.
