

Audi Care Agreement | Terms & Conditions

Coverages

Audi Care consists of six different coverages providing prepaid scheduled maintenance services. The details are provided below. The coverage that applies to your vehicle is specified in your Audi Care contract and is determined by the asterisk (*) next to it.

What is not covered:

All parts and services not listed in the *Audi Warranty & Maintenance Booklet* included with the vehicle will not be covered. Examples of items not covered include, but are not limited to: mechanical breakdown repairs, hoses, brake pads and linings, and wheel alignment and balancing. In addition, Audi of America, Inc., will not pay for maintenance services that are performed by any party other than an authorized Audi dealership, or for loss of time, inconvenience or other incidental or consequential losses.

Audi Care | MY 2010 through 2016 Purchase

- Audi Care prepaid scheduled maintenance is available for purchase at authorized Audi dealerships in the U.S. It may be purchased for all MY 2010 through 2016 Audi vehicles sold or leased in the U.S.
- Audi Care may be purchased at the time of the retail sale or lease of an Audi vehicle through an authorized Audi dealer, or at a later date. When
 Audi Care is purchased at a later date, you will not be able to roll the cost into your monthly payment. Scheduled maintenances that have already
 been performed will not be prorated. It is highly recommended that you purchase Audi Care at the time you purchase/lease your vehicle, or before
 the 15k scheduled maintenance, in order to receive the full cost-saving benefits.
- The price you will pay for Audi Care is specified in your Audi Care contract.
- Dealer sets final price. Plus applicable taxes. Tax on parts supplied may be due at the time of each scheduled maintenance, as required by state
 and/or local regulations where the work is performed.

Audi Care scheduled maintenance services

To be performed at the event that occurs first:

15,000 miles or 12 months after the 5,000-mile scheduled maintenance

25,000 miles or 12 months after the 15,000-mile scheduled maintenance

35,000 miles or 12 months after the 25,000-mile scheduled maintenance

45,000 miles or 12 months after the 35,000-mile scheduled maintenance

Audi highly recommends that after the 5,000-mile or 6-month maintenance service, a maintenance service be performed at 10,000 miles or 12 months after the previous maintenance service, whichever occurs first, as presented in the chart above. For complete information, refer to the *Audi Warranty & Maintenance Booklet* included with the vehicle. All Audi Care prepaid scheduled maintenance expires at 57,000 miles or 66 months from the original vehicle in-service date, whichever occurs first. Please see your Audi dealer for complete details.

 date. When and additional Audi Care package is purchased at a later date, you will not be able to roll the cost into your monthly payment.
 Scheduled maintenances that have already been performed will not be prorated. It is highly recommended that you purchase Audi Care at the time
 you purchase/lease your vehicle, or before the mileage specified for the first scheduled maintenance in any package, in order to receive the full
 cost-saving benefits.
